"We are very pleased to achieve this important milestone towards our planned opening in the fourth quarter 2007. The regulatory approval process continues on track with the FDIC and Federal Reserve System. We are assembling an outstanding team of talented and committed community bankers and have begun our business calling program to shareholders and other members of our business community. While we can not accept deposits until we open, an integral part of our business model is to have our shareholders actively involved in the growth of their bank. That includes not only banking with us, but also seeking the referrals of their friends, colleagues and family members to First Virginia Community Bank." First Virginia Community Bank (I.O.) is a Fairfax, Virginia headquartered state chartered bank, currently in organization.
